The accesses to this site are through a lay-by which will reduce the size of the much used lay-by – visitors to the surgery, the schools, Speedy's café and the burger van use this lay-by as there is nowhere else to park off the A16 when the school and surgery carparks are full. There is a problem with poor land drainage in this area of the A16. The property is significant in the history of Stickney, being one of the older properties in this area of the village – where the old blacksmiths was sited. Some of the trees have been removed and reduced the wildlife that was on the land. The plans show 9 large family properties with parking for only 10 vehicles. These family properties will put additional strain on the already over-stretched surgery.
