Dist Cllrs Ashton & Jones reported:

- a. ELDC are supporting a Public Sector Hub at Horncastle together with Boston College and LCC. The aim is for ELDC to relocate from Tedder Hall.
- b. ELDC have been given the go ahead to set up an investment company to allow ELDC to make a profit.
- c. ELDC are just ahead of their targets, but still feel improvements need to be made.
- d. Data from the planning annual satisfaction survey will change to allow for more useful data to be collected for use by future applicants.
- e. ELDC could receive a grant of £25m from Central Government Better Communities Grant
